◆ **Early Payment Discount**

Participants that choose to pay the entire balance for Jamboree will receive a discount of \$150. In order to qualify for the discount, the entire payment of **\$3050** must be received no later than January 13th 2012.

**Late Payment**

- ◆ Participants are responsible to make all payments on time.
- ◆ Payments are considered late if they are not received and processed at one of the 4 council service centers before the close of business on the day that the payment is due. As not all service centers are open during normal business days you need to check the operating hours for your local center.
- ◆ If the payment date is not a normal business day, the payment date is extended to the next business day.
- ◆ Arrangements or exceptions must be made in writing **before the payment is due** and must be approved by the Jamboree Committee.
- ◆ Participants will be removed from the jamboree troop and moved to the **bottom of the waiting list** for missed payments.

**Refunds**

- ◆ The \$100 deposit is non-refundable
- ◆ All refund requests need to be made in writing to the Jamboree Committee.
- ◆ Payments made to date will be refunded less deposit upon sign up of replacement troop member.
- ◆ Early payment of all Jamboree fees is encouraged
  - ◆ Participants that make payments ahead of schedule and are requesting a refund will be eligible to receive a refund for the amount in excess of what is currently due at the time, when the refund is requested.
  - ◆ Payments made to date will be refunded less deposit upon sign up of replacement troop member.

**Waiting List**

- ◆ Initial placement on the waiting list is based upon the date and time of payment of the deposit.
- ◆ While you are on the waiting list, you do not have to make any of the scheduled payments other than the initial deposit of(\$100).
- ◆ If you are not moved into one of the jamboree troops because all the participants slots are filled, then your deposit will be refunded.
- ◆ If you are moved into one of the jamboree troops or crews, you will have thirty (30) days to bring your registration payments current unless other arrangements are made in writing with the Jamboree committee.
